President's Message by Cheri Jeffcoat

Where did the ride year go? Even though I wasn't competing, just working, it seemed to speed by.

What's new? My horse Saku, suffered another injury on the same leg and is no longer fit to go Open. The issue would always be one of the infamous "intermittent" lameness problems. Of course, I could push it but that would be such a disservice to her and even worse would be an example of bad horsemanship on my part. So, I have to bite the bullet and make a change. Drat, when I bought her there was the old "this is the last horse I am going to start in CTR" floating in the back of my brain. Oh well, I don't do well without challenges in my life! Time for me to "suck it up"!

What else is new? Thankfully the National BOD did not pass the obstacle rule. It would have caused some real havoc in the 46 states that have equine liability laws. The NBOD passed several clarifications but those that had a lot of member dissension were tabled. That is good for now. We must remain vigilant!

I judged one ride in Region 6 this year. I was somewhat surprised that it appeared that as competitors, we really seem to zombie out, not thinking, not paying attention to our horses. I went home after the ride and just could not resolve what the problem is. I know folks care, I know we want to do well, I know we want to have fun and be safe BUT there was something missing. One of the things I saw was that there were so many conversations going on that very little attention was being paid to the horse. And, then when the rider asked the horse to do something the rider had problems gaining the horses' attention because the rider had ignored the horse for a long time, just a passenger. I know I have not been competing but it seems to me the focus was just not on our horses. Repeatedly, I heard "my horse does this at home". I am not buying this. We are NOT at home, where is the training process failing? Are we paying the same focused attention on our horses at the ride as at home? Are we really putting our horses in different situations to reinforce that they can side-pass and back ANYWHERE, not just "at home"? When riding "at home" do we take advantage of different ditches, trees, gates etc or do we use the exact same places every time? Are we mixing up our practice areas? Are we thinking? Are we really working on a partnership with our horses or are we more interested in our conversations?

I love the camaraderie and people in our sport but I also recognize that we are there to compete. When we compete the focus should be on our partner. Maybe our theme for 2008 should be "Striving for Excellence". Excellence is not a dirty word. I think I will tape a note to the front of my saddle to remind me that I will "Strive for Excellence" and hopefully have my brain working at the same time!

Given what I have written, we have all winter to think about what we need to do to work on the partnership with our horses. If I sound "preachy" I apologize; however that does not take away what I observed. In my heart of hearts, I truly believe we have the "best" horses and riders in Region 6, we just need to rededicate ourselves to being the very best and "Strive for Excellence". See ya' at convention in Des Moines.

EKAHA HILL & DALE 2007

The weekend of June 16 -17 brought to NATRC and Region 6 the 27th consecutive year of Hill & Dale. And 27 years absolutely does not seem possible.

Some years the ride has gone so smoothly we await the fall of the other shoe, (human or horse), and others are full of errors, items forgotten etc. This year we saw the implementation of the much heralded new RMS entry program and indirectly it almost caused the ride to be cancelled. 13 days prior to the ride we had 17 entries and that is not enough to make any ride worth while. We put the word out through various channels that the ride was in jeopardy and low and behold we started 54. This is a ride manager's nightmare and a ride secretary's major headache. In addition, the Hillsdale area experienced numerous heavy rainfalls a few weeks prior to the ride - to the point we wondered if it would be too dangerous to ride. But Mother Nature came through with bright sunshine and brisk Kansas style winds to help dry the trails.

Our vet judge, Dr. Darlene Wehr, was a hit with the riders. She and her husband make a good team. Horsemanship judge Jean Green was her usual thorough self continually offering pointers and suggestions to riders. We hadn't seen Jean for several years and it was good to have her here again.

Our awards ceremony was capped by the presentation of the Gerald Peterson Memorial Trophy. The award is in honor of the late Gerald Peterson who was instrumental in the early days of Hill & Dale and continued to his death. The Petersons were breeders and strong supporters of the Arabian breed and the award criteria is the top combined horse and horsemanship score for any purebred or part bred Arabian. This year the award and trophy have a new home with Christine Abbott.

If you have ever attended one of my rides you have heard me say how thankful I am to have such a great group of workers, something ride management cannot do without. And, to that end, 2007 was the final year for our trusted trail master, Ginny Peterson in handling that job. I can't even think about how much more difficult my job would have been without her for all, and I do mean ALL, 27 years. Thanks is an insignificant recognition. Competitors have Ginny to thank also for the great trails and markings. For all practical purposes, she is responsible for the trails even existing around Hillsdale Lake. We were there before the State of KS took the area over; we were there before there was any water in the lake; we were there before the road over the dam was paved; and we were there before any local saddle clubs staked claim to the area and trails. She is also the author of the name Saddle Ridge for the equine campground on which we camp. Tell Ginny how much you appreciate what she has done for you and your safety.

Ginny and I recently had the pleasure of speaking at a meeting of the Hillsdale Ruritan club. This is the group that has provided the Saturday night BBQ for so many years and they invited us to talk about our sport and what sets us aside from other distance programs. (And, we found that night that they cook other things equally well. Boy, did we eat!!) And we have special long time ties to some members of this group such as Dave Green who headed up the Corps of Engineers at the time we started 27 years ago. It's always nice to have "contacts" in high places. And Bill Smotherman who heads up the Ruritan BBQ effort and on whose land we camped for a few years before Saddle Ridge came to be. If you have been around long enough, you will remember Bill owns the pasture on the SE corner where you now turn North toward the water tower.

All in all, 2007 was another good year for us and we expect to see you in 2008. Mark your calendars for the 28th ride; scheduled for June 14-15, 2008. This is a week earlier than normal to allow yours truly to take a "personal week". It also puts a week between H&D and Cedar Creek.

Equine Care Winter Checklist

Water: Adequate water intake is vital. Horses will drink best if their water source is warmed to about 60 degrees or warmer. A combination of a dry forage diet and low water intake can increase the incidence of impaction colic. Tank heaters and heated water buckets are inexpensive compared to a vet bill for colic treatment! Adding soaked beet pulp to the diet is another way to increase fluid intake.

Shelter: Horses are well-adapted to living outside in the cold, but sometimes additional shelter becomes necessary for comfort, such as extreme wind-chill or a combination of wet and cold. If plenty of trees are not available for a windbreak, a run-in shelter or snug stall might be in order. Blanketing is seldom necessary unless no other shelter is available. Even then, only the very old, very young, underweight or ill horses are likely to need the extra protection.

Calories/weight: As the temperature drops, horses burn more calories to produce body heat and will need an increase in feed, especially hay. Be sure to monitor weight with a weight tape or by frequently feeling the ribs and backbone. Don't depend on a visual exam, as the fluffy winter coat can be deceiving! If weight starts to fall, an addition of more fat to the diet might be in order, such as mixing some corn or soy oil into the grain.

Hoof/health care: Although hoof growth decreases in the winter, don't neglect the farrier's visits. And, keep up your regular de-worming routine, as a heavy worm load can be hard on a horse that is dealing with cold-weather stress.

By-laws and Rules – Lory Walls – Please inform membership that proposed rule changes come to the national board from members in the organization. The NBOD does not sit around the table and dream up rule changes to present to membership; too many other things to take care of.
